 - During midspin to end of arena, failure to change leads beyond 1 stride but prior to next maneuver
 - Hit or step on leg, pole, or obstacle
 - Break gait at walk or trot 2 strides or less
 - Both feet in space or split pole on-logs over
 - Slipping over or failing to stand in a required space
 - Increase number of strides between poles

 - Trotting beyond two (2) strides, out less than 1/2 circle or 1/2 the arena
 - Sliding past markers or cones by more than 10 feet
 - Freezing up in spots or runbacks

- Any break of gait at logs
 - A break of gait at walk or trot for more than two (2) strides
 - Shooting down or severely disturbing an obstacle
 - Stepping outside the confines of falling or jumping off or out of obstacle with designated boundaries with one foot once the foot has entered the obstacle
 - Striking with a pole or one element that is part of a series of obstacles with one foot

 - Use of raw hand to react feet
 - First and second refusals (5 points each)
 - Balk or attempt to evade an obstacle by shying or backing more than 2 strides away
 - Stepping outside the confines of falling or jumping off or out of an obstacle with designated boundaries with more than one foot once the foot has entered the obstacle
 - Missing evading a pole or one element that is part of a series of obstacles with more than one foot
 - Failure to demonstrate correct gait between obstacles as designated
 - Plaintive disobedience, bucking, rearing, etc.

 - Stepping outside the confines of falling or jumping off or out of obstacles with designated boundaries with one foot once the foot has entered the obstacle.
 - Misaligning a pole or one element that is part of a series of obstacles with one foot.

- Balk or attempt to evade an obstacle by shying or backing more than 2 strides away.

- Missing evading a pole or one element that is part of a series of obstacles with more than one foot.
