 d) Slipping over or failing to step into required space.
 e) Spill pole on lobe over.
 f) Incorrect number of strides, if specified.

- Three (3) Point Penalty:
 a) Incorrect or break of gait at walk or trot for more than two strides.
 b) Use of lead or break of gait at lope.
 c) Starting a lope departure at a trot for three (3) strides or more.
 d) Knocking down an elevated pole cone, barrel, plant, obstacle or severely disturbing an obstacle.
 e) Fall or jumping off or out of an obstacle with designated boundaries, bridge or water box, with one foot once the horse has gotten onto or into that obstacle.
 f) Stepping outside the confines of an obstacle with designated boundaries (i.e. back through, 360 box, side pass) with one foot once the horse has entered the obstacle.
 g) Missing or evading pole that is part of a series of an obstacle with one foot.

- Five (5) Point Penalty:
 a) First and second cumulative refusal, balk or attempting to evade an obstacle. A refusal at addressing an obstacle is taking two (2) or more steps backwards the rope gate.
 b) Letting go of the gate or dropping the rope gate.
 c) Use of hand to instill fear.
 d) Ground tie - second rein not touching ground.
 e) Stepping outside the confines of falling or jumping off or out of an obstacle with designated boundaries with more than one foot once the foot has entered the obstacle, including missing one segment of an obstacle on a line of travel with two feet.
 f) Blatant disobedience (kicking out, bucking, rearing or striking).
 g) Failure to demonstrate correct gait between obstacle as designated.
 h) Failure to dally on the log drop.

- Disqualifications:
 a) Use of more than one (1) finger between reins.
 b) Use of two (2) hands (except for snaffle bit hackamore or mecate as designated two hand) or changing hands on reins, except for junior horses for shown with snaffle hackamore mecate, only one (1) hand may be used on the reins, except when it is permissible to change hand to work an obstacle.
 c) Verbal abuse or any inhumane treatment of horse.
 d) Use of force other than outlined in the rule book.
 e) Performing the obstacle incorrectly or other than in the specified order or no attempt to perform the obstacle.
 f) Equipment failures that delay completion of pattern.
 g) Fall to the ground by horse or rider.
 h) Failure to enter, exit or work obstacle from the correct direction, including more than 1/2 turn.
 i) Dropping object required to be carried on course or using your rope before attempting to rope steers.
 j) Failure to follow the correct line of travel between obstacles and/or work obstacles in any manner other than how it's described by the course.
 k) Riding outside the designated boundary markers.
 l) Third cumulative refusal, balk or evading an obstacle by stying or backing.
 m) Gate must be open and closed, failure to leave gate as found will result in disqualification.
 n) Failure to dismount to load and unload at the trailer. Horses must remain saddled as they load and unload from the trailer.
 o) Letting go of reins when attempting to rope the dummy.

 b) Out of lead or break of gait at lope.
 c) Starting a lunge departure at a trot for three (3) strides or more.
 d) Knocking down an elevated pole cone, barrel, plant, obstacle or severely disturbing an obstacle.
 e) Fall or jumping off or out of an obstacle with designated boundaries, bridge or water box with one foot, once the horse has gotten onto or into that obstacle.
 f) Stepping outside the confines of an obstacle with designated boundaries (i.e.: back through, 360 box, aids pass) with one foot once the horse has entered the obstacle.
 g) Missing or evading pole that is part of a series of an obstacle with one foot.

- Five (5) Point Penalty.
 a) First and second cumulative natural, balk or attempting to evade an obstacle. A refusal is addressing an obstacle is taking two (2) or more steps backwards.
 b) Letting go of the gate or dropping the rope gate.
 c) Use of hand to instill fear.
 d) Ground lie - second rein not touching ground.
 e) Stepping outside the confines of falling or jumping off or out of an obstacle with designated boundaries with more than one foot once the foot has entered the obstacle, including missing one element of an obstacle on a line of travel with two feet.
 f) Bizarre disobedience (kicking out, bucking, rearing or striking).
 g) Failure to demonstrate correct gait between obstacle as designated.
 h) Failure to dally on the log drop.

- Disqualifications
 a) Use of more than one (1) finger between reins.
 b) Use of two (2) hands (except for snaffle bitback/more/more as designated two hand) or changing hands on reins, except for junior horses for shown with snaffle/backmore/more, only one (1) hand may be used on the reins, except when it is permissible to change hand to work an obstacle.
 c) Whisk above or any inhumane treatment of horse.
 d) Use of force other than outlined in the rule book.
 e) Performing the obstacle incorrectly or other than in the specified order or no attempt to perform the obstacle.
 f) Equipment failures that delay completion of pattern.
 g) Fall to the ground by horse or rider.
 h) Failure to enter, exit or work obstacle from the correct direction, including more than 1/2 turn.
 i) Dropping object required to be carried on course or losing your rope before attempting to rope steer.
 j) Failure to follow the correct line of travel between obstacles and/or work obstacles in any manner other than how it's described by the course.
 k) Riding outside the designated boundary markers.
 l) Third cumulative refusal, balk, or evading an obstacle by flying or backing.
 m) Gate must be open and closed, failure to leave gate as found will result in disqualification.
 n) Failure to dismount to load and unload at the trailer. Horses must remain saddled as they load and unload from the trailer.
 o) Letting go of reins when attempting to rope the dummy.

- e) Fall or jumping off or out of an obstacle with designated boundaries, bridge or water bar with one foot once the horse has gotten onto or into that obstacle
- f) Dropping outside the confines of an obstacle with designated boundaries (i.e., back through 360 box, side post) with one foot or on the horse has entered the obstacle
- g) Missing or evading pole that is part of a series of an obstacle with one foot

Five (5) Point Penalty:

- a) First and second cumulative refusal, back or attempting to avoid an obstacle. A refusal is avoiding an obstacle by taking two (2) or more steps backward
- b) Letting go of the gate or dropping the rope gate
- c) Use of hand to assist feet
- d) Ground tie - second rein not touching ground
- e) Stepping outside the confines of falling or jumping off or out of an obstacle with more than one foot once the foot has entered the obstacle, including rearing and circling of an obstacle on a row of hand with two feet
- f) Excessive disobedience (backing out, backing, rearing or sitting)
- g) Failure to demonstrate correct gait between obstacle as designated
- h) Failure to duty on the jog end

Disqualifications:

- a) Use of more than one (1) leg, between rails
- b) Use of two (2) hands (except for snaffle with jumpers) except as designated two hands or changing hands on reins, except for junior horses for show with snaffle-jumpers; one (1) hand may be used on the reins, in case when it is permissible to change hand to work an obstacle
- c) Verbal abuse or any inhumane treatment of horse
- d) Use of some other than outlined in the rule book
- e) Performing the obstacle incorrectly or other than in the specified order or no attempt to perform the obstacle
- f) Equipment failure that delay completion of pattern
- g) Fall to the ground by horse or rider
- h) Failure to enter, exit or work obstacle from the correct direction including more than 1/2 turn
- i) Dropping object required to be carried on course or being out of rope barrier attempting to rope steer
- j) Failure to follow the correct line of travel between obstacles and/or work obstacles in any manner other than how it's described by the course
- k) Riding outside the designated boundary markers
- l) Third cumulative refusal, balk, or evading an obstacle by flying or backing
- m) Gate must be open and closed, failure to leave gate as found will result in disqualification
- n) Failure to dismount to load and unload at the trailer. Horses must remain seated as they load and unload from the trailer
- o) Letting go of reins when attempting to rope the dummy

Five (5) Point Penalty

- a) First and second cumulative refusal, balk or attempting to evade an obstacle. A refusal is occurring an obstacle is taking two (2) or more steps backwards.
- b) Lifting up of the gate or stepping the rope side
- c) Use of hand to assist fear
- d) Ground tie - second rear leg touching ground
- e) Stepping outside the confines of falling or jumping off or out of an obstacle with designated boundaries with more than one foot once the foot has entered the obstacle, including missing one element of an obstacle on a line of travel with two feet
- f) Disturb, disintegrate, evading out, stepping, rearing or striking
- g) Failure to demonstrate correct gait between obstacle as designated
- h) Failure to duty on the leg drive

Disqualifications

- a) Use of more than one (1) finger between reins
- b) Use of two (2) hands (except for snaffle with chambered mouthpiece as designated in hand) or changing hands on reins. Snaffle for junior horses for shown with snaffle/chambered mouthpiece, only one (1) hand may be used on the reins, in case when it is permissible to change hands to work an obstacle
- c) Whips above or any inhumane treatment of horse
- d) Use of ropel other than outlined in the rule book
- e) Performing the obstacle incorrectly or other than in the specified order or no attempt to perform the obstacle
- f) Equipment failure that delay completion of certain
- g) Fall to the ground by horse or rider
- h) Failure to enter, exit or work obstacle from the correct direction including more than 70 turn
- i) Obstacle object required to be carried on course or being rear rope before unstepping to rope steer
- j) Failure to follow the correct line of travel between obstacles and/or work obstacles in any manner other than how its described by the course
- k) Riding outside the designated boundary markers
- l) Third cumulative refusal, balk or evading an obstacle by flying or backing
- m) Gate must be open and closed, failure to leave gate as found will result in disqualification
- n) Failure to dismount to load and unload at the trailer. Horses must remain saddled as they load and unload from the trailer
- o) Letting go of reins when attempting to rope the dummy
