c) Fingers between the reins in a bridle. More than one (1) finger between reins when showing in any bridle other than a snaffle or bosal.
d) Illegal equipment.
e) Leaving the arena before time expires.
f) Fall of horse or rider.
g) Working over three (3) head of cattle in the 2 1/2 minutes. Quitting or losing the third cow worked while time is still on the clock.
h) A judge may blow the whistle at any time during the work if they feel the cattle or horse are being mishandled, abused or deem the situation unsafe.
