Five (5) Point Penalties

- a) Blatant disobedience
- b) Spurring in front of the cinch.
- c) Excessive herd help to be applied when the helpers keep cows from going back to the herd

Disqualifications

- a) Allowing cow to return to the herd after it is clearly separated or crosses back over the time/foul line after attempting to be penned. A cow is considered to be "back in the herd" when it touches another cow in the herd.
- b) Horse turns tail to cattle
- c) Falls to ground of horse or rider during any portion of the run.
- d) Penning trash cow
- e) Two hands on reins except when exhibiting a junior horse in either a snaffle bit or hackamore (bosaf).
- f) illegal equipment
- g) Excessive disturbance of herd to the point that the exhibitor is asked to leave the arena.
