 - Letting go of the gale or dropping the rope gale.
 - Use of hand to instill fear.
 - Ground tie - second rein not touching ground.
 - Stepping outside the confines of falling or jumping off or out of an obstacle with designated boundaries with more than one foot once the foot has entered the obstacle including missing one element of an obstacle on a line of travel with two feet.
 - Blatant disobedience (kicking out, bucking, rearing or striking).
 - Failure to demonstrate correct gait between obstacle as designated.
 - Failure to dally on the log drag.

- Disqualifications:
- Use of more than one (1) finger between reins.
 - Use of two (2) hands (except for snaffle bitbackmaster/marets as designated two hand) or changing hands on reins, except for junior horses for shown with snaffle/backmaster/marets, only one (1) hand may be used on the reins, except when it is permissible to change hand to work an obstacle.
 - Willful abuse or any inhumane treatment of horse.
 - Use of ropes other than outlined in the rule book.
 - Performing the obstacle incorrectly or other than in the specified order or no attempt to perform the obstacle.
 - Equipment failures that delay completion of pattern.
 - Fail to the ground by horse or rider.
 - Failure to enter, exit or work obstacle from the correct direction, including more than 1/4 turn.
 - Dropping object required to be carried on course or losing your rope before attempting to rope steer.
 - Failure to follow the correct line of travel between obstacles and/or work obstacles in any manner other than how it's described by the course.
 - Riding outside the designated boundary markers.
 - Third cumulative refusal, balk, or evading an obstacle by shying or backing.
 - Gate must be open and closed, failure to leave gate as found will result in disqualification.
 - Failure to dismount to load and unload at the trailer. Horses must remain saddled as they load and unload from the trailer.
 - Letting go of reins when attempting to rope the dummy.

 - c) Use of hand in self fear
 - d) Ground tie - second rear not touching ground
 - e) Dropping outside the confines of being or jumping off or out of an obstacle with designated boundaries with more than one foot once the foot has entered the obstacle, including missing one element of an obstacle on a line of travel with two feet
 - f) Balked disobedience including out-bucking, rearing or striking
 - g) Failure to demonstrate correct gait between obstacle as designated
 - h) Failure to dally on the log dip

- Disqualifications:**
- a) Use of more than one (1) finger between reins
 - b) Use of two (2) hands (except for double reins) or changing hands on reins, except for junior horses for whom with punishment may be waived, any one (1) hand may be used on the reins, except when it is necessary to change hands to work an obstacle
 - c) Whisk abuse or any inhumane treatment of horse
 - d) Use of relief other than outlined in the rule book
 - e) Performing the obstacle incorrectly or other than in the specified order or no attempt to perform the obstacle
 - f) Equipment failures that delay completion of pattern
 - g) Fall to the ground by horse or rider
 - h) Failure to enter, exit or work obstacle from the correct direction, including more than 90 turn
 - i) Dropping object required to be carried on course or leaving rope unless attempting to rope steer
 - j) Failure to follow the correct line of travel between obstacles and/or work obstacles in any manner other than how it's described by the course
 - k) Roping outside the designated boundary markers
 - l) Third cumulative refusal, balk, or evading an obstacle by striking or backing
 - m) Gate must be open and closed; failure to leave gate as found will result in disqualification
