- d) Penning trash cow.
- e) Two hands on reins except when exhibiting a junior horse in either a snaffle bit or hackamore (bosal).
- f) Illegal equipment
- g) Excessive disturbance of herd to the point that the exhibitor is asked to leave the arena.
