f) Blatant disobedience (kicking out, bucking, rearing or striking)  
g) Failure to demonstrate correct gait between obstacle as designated  
h) Failure to duty on the log drive

Disqualifications:  
a) Use of more than one (1) finger between reins  
b) Use of two (2) hands (except for snaffle or hackamore) or changing hands on reins, except for junior horses for shown with snaffle/hackamore/mecate, only one (1) hand may be used on the reins, except when it is permissible to change hand to work an obstacle  
c) Verbal abuse or any inhumane treatment of horse  
d) Use of tools other than outlined in the rule book  
e) Performing the obstacle incorrectly or other than in the specified order or no attempt to perform the obstacle  
f) Equipment failures that delay completion of pattern  
g) Fall to the ground by horse or rider  
h) Failure to enter, exit or work obstacle from the correct direction, including more than 1/4 turn  
i) Dropping object required to be carried on course or leaving your rope before attempting to rope steer  
j) Failure to follow the correct line of travel between obstacles and/or work obstacles in any manner other than how it's described by the course  
k) Riding outside the designated boundary markers  
l) Third cumulative refusal, balk, or evading an obstacle by shying or backing  
m) Gate must be open and closed, failure to leave gate as found will result in disqualification

- Five (5) and beyond cumulative refusal, balk or attempting to evade an obstacle. A refusal or addressing an obstacle is taking two (2) or more steps backwards
  - Letting go of the gate or dropping the rope cone
  - Use of hand to yield fear
  - Ground lie - second rein not touching ground
  - Throwing surface the confines of falling or jumping off or out of an obstacle with designated boundaries with more than one foot once the foot has entered the obstacle, including missing one element of an obstacle on a line of travel with two feet
  - Obvious disobedience (kicking out, bucking, rearing or striking)
  - Failure to demonstrate correct gait between obstacle as designated
  - Failure to stay on the lag during

- Three (3) Point Penalty:
- Incorrect or break of gait at walk or trot for more than two strides
  - Out of lead or break of gait at lope
  - Starting a lope departure at a trot for three (3) strides or more
  - Knocking down an elevated pole, cone, barrel, plant, obstacle or severely disturbing an obstacle
  - Fail or jumping off or out of an obstacle with designated boundaries, bridge or water box, with one foot once the horse has gotten onto or into that obstacle

- Five (5) Point Penalty:
- First and second cumulative refusal, balk or attempting to evade an obstacle. A refusal is addressing an obstacle is taking two (2) or more steps backwards
  - Letting go of the gate or dropping the rope gate
  - Use of hand to instill fear
  - Ground ba - second rein not touching ground
  - Stepping outside the confines of falling or jumping off or out of an obstacle with designated boundaries with more than one foot once the foot has entered the obstacle, including missing one element of an obstacle on a line of travel with two feet
  - Barrier disobedience (shaking out, bucking, rearing or snorting)
  - Failure to demonstrate correct gait between obstacle as designated
  - Failure to dally on the log drape

- Disqualifications:
- Use of more than one (1) finger between reins
  - Use of two (2) hands (except for snaffle or hackamore) inside or outside of designated two-hand or changing hands on reins, except for junior horses for show with snaffle/hackamore/moose, only one (1) hand may be used on the reins. Except when it is permissible to change hand to work an obstacle
  - Verbal abuse or any inhumane treatment of horse
  - Use of tool other than outlined in the rule book
  - Performing the obstacle incorrectly or other than in the specified order or no attempt to perform the obstacle
  - Equipment failures that delay completion of pattern
  - Fail to the ground by horse or rider
  - Failure to enter, exit or work obstacle from the correct direction, including more than 1/2 turn
  - Dropping object required to be carried on course or using your rope before attempting to rope steer
  - Failure to follow the correct line of travel between obstacles and/or work obstacles in any manner other than how it's described by the course
  - Riding outside the designated boundary markers
  - Third cumulative refusal, balk, or evading an obstacle by straying or backing
  - Gate must be open and closed, failure to leave gate as found will result in disqualification
  - Failure to dismount to load and unload at the trailer. Horses must remain saddled as they load and unload from the trailer
  - Letting go of reins when attempting to rope the dummy

 f) Barient disobedience (kicking out, bucking, rearing or striking).
